Question:

Marie Holt: Has the congregation had an opportunity as in the past via notification in the Sonlight to nominate deacons?

Peter Thompson indicated the opportunity was shared at the May 2024 church conference. Per normal circumstances, voting would take place at next Sunday's services so an answer to Marie's question will be sorted out during the course of tonight's conference.

## **Buildings Committee (Danny Holland)**

- The Journey to Bethlehem house is now in appropriate condition to be burned by the Apex Fire Department sometime in October.
- Chapel roof repair: working on getting bids. A substantial check from insurance has been received to go towards that expense.
- A large water usage was detected when our campus was not in use. The issue was located and corrected and the Town of Apex issued us a credit.
- Buildings B & C: Hinge guards have been installed as recommended/required by Selective Insurance Risk management team.
- The most recent storm caused metal to be torn off the fascia on Building C. Repairs are already in process.
- Building C air condition unit sustained a lightning strike: \$8,500 repair of which insurance is paying all but \$1,500.
- All kitchen equipment: repaired and ready for Wednesday night cooking
- All trees around campus: pruned or removed.

David Wells: Has any thought been given to painting the steeple at the same time as repairing the roof?

Danny noted it has been discussed/considered but is not being pursued at this time due to cost. We will take a look at that again in 2025.

- Aaron and Alexis
- The Buenos (Panama)- next Salem trip is planned for Summer 2025
- Disaster Relief:
  - Ten Salem members have served this summer in multiple states.
  - NC Baptist on Mission Rebuild Center in Lumberton opportunities.
  - The next Salem trip is scheduled September 19-21, 2024.
- Children:
  - Goal is to offer two Foster Family respite nights yearly. The next one is scheduled September 21, 2024.
- Community Outreach:
  - Salem is continuing to sponsor on-site Refugee Hope Partners (RHP) for homework assistance.
  - A medical clinic through BOM is scheduled November 9, 2024
- Local Poverty:
  - Salem has provided school supplies to 60 children of families in need.

## Trustees Report (Brad Chaney)

### Loan History & Update

- \$5.8M Original loan amount (June 2011)
- Refinanced \$3.2M @ 3.0% FIXED rate (Sep 2021)
- Regular monthly payment = \$24,776/month
- Supplemental principal payments reduce balance and is based on giving to the Building Debt Retirement fund
- **You have generously given \$90,000 YtD to the debt fund**
- **50% of refinanced loan amount has been paid in 3 yrs with a current balance of \$1.6M Thank You!!!**
- **Mthly Pymt + Additional \$10K/mth) closes loan by Sept 2028**

## Annual Financial Audit

- Salem Church & Pre-School Financial Audit for fiscal year 2023 was completed April 29-30 by C. DeWitt Foard & Co. a certified public accounting firm
- Results indicated that financial statements continue to be accurately presented in conformity with the organization's basis of accounting and no immediate issues were identified

## Contracts

- Kitchen & Food Services annual contract renewal to be signed w/ Good Eats Catering (Andy & Geoff) for Wednesday evening meals resuming this Fall

## Stewardship Committee Report (Mark Harper)

- October to July (10 of 12 months) a financial snapshot of revenue, budget and expenses to date appears to project that revenue will exceed both budget and expenses this year.
  - Revenue: \$1,568,789
  - Budget: \$1,416,569
  - Expenses: \$1,302,398
- The 2024-2025 Church Budget has been shared and will be voted on in September. The Committee was targeting a 1% increase and the proposed budget reflects a 1.9% increase.
